## **PACT ACT EXPIRATION DATE**

As we get closer to the anniversary date of the signing of the PACT ACT all Post Service Officer are to ensure all veterans are informed that they need to File their claim prior to August 9, 2023.

By filing their claim prior to this date, they can receive back pay from the date of the signing of the PACT ACT to August 9, 2022

All claims filed after this date (August 9, 2023) will not receive back pay compensation.

## **HEALTH CARE ENROLLMENT**

Veterans with service after September 11, 2001, will have special health care enrollment eligibility that expires on September 30, 2023.

Post Service Officers need to inform their Post Members of these dates.

## **DEPENDENCY AND INDEMNITY COMPENSATION CLAIMS**

There is an increase in filing claims for Dependency and Indemnity Compensation for surviving spouse and dependent children or parent(s) of a veteran who died or died in the line of duty or due to a service-related injury or illness. Post Members need to immediately contact their accredited VSO in the Area (Please see attached current accredited Service Officers/Claims Consultants contact information) and make an appointment for the Family. Post Service Officers are not authorized to sign any forms related to any type of claim.

#### STATE VFW POST OFFICER TRAINING SESSIONS – REGIONAL EVENTS

Training for Post Service Officers will take place in the upcoming year and is mandatory for all Post Service Officers. The State will be divided into (3) three areas to allow maximum attendance at training. The first (1st) training session will be held at the Mid-Winter Conference January 19th thru January 21st in Cranberry, PA

#### **SENATE BILLS/LEGISLATIVE**

US SB 2078: A bill to direct the Secretary of Veterans Affairs to take actions necessary to ensure that certain individuals may update the burn pit registry with the cause of death of a registered individual, and for other purposes.

US SB 1952: A bill to amend title 38, United States Code, to expand eligibility for care from the Department of Veterans Affairs to include members of the reserve components of the Armed Forces, and for other purposes.

US SB 2431: A bill to require the Secretary of Labor, in coordination with the Secretary of Veterans Affairs, to carry out a grant program to assist certain members or former members of the Armed Forces in transitioning to civilian life, and for other purposes.

US SB 2294: A bill to amend title 38, United States Code, to furnish hospital care and medical services to veterans and dependents who were stationed at military installations at which those veterans and dependents were exposed to perfluorooctanoic acid or other... Toxic Exposure
